Standard Deduction Increased again.

Charitable contributions are deductible (up to \$300) for those who do not itemize.

Stimulus payments went out around April or May 2019. We need to know how much stimulus you received.

→ note: the Stimulus is not taxable!

Is this your first year with us? Bring Photo ID and SS card(s), dates of birth for taxpayer, spouse & dependents. Also, bring copies of your 2019 and maybe even 2018 tax returns.

INCOME ITEMS

Wages, Salary and Other Income Items--Form W-2, Form 1099-MISC; Social Security—Form 1099-SSA

Unemployment--Form 1099-G; Retirement--Form 1099-R; Interest & Dividends--1099-INT 1099-DIV

Sales of Stocks, Bonds or Other Assets--Form 1099-B from your stockbroker.

Income from Partnerships, S Corporations, Trusts and Estates--Schedules K-1

Self-employed Business or Farm? -- A detailed summary of business/farm income & expenses. Remember Business Mileage log

→ Home Office Expense: Mortgage Interest, Property Tax; HO Insurance; Utilities; Repairs & Maintenance; HOA fees; etc.

Rental Property? A detailed summary of Rental Income & Expenses. Remember Business Mileage log

Sale of your Residence -bring the long closing statement from the title company & your cost info & date purchased

DEDUCTIONS

The 2020 Standard Deduction is: Married Joint: \$24,800; Single: \$12,400; Head of Household: \$18,650.

For each person over 65 or blind add \$1,300 to the above amounts.

Tax Savings note: It will help you to itemize deductions only if your itemized deductions exceed your Standard Deduction.

Medical and Dental Expenses, includes Health Insurance & Long-term care premiums (deductible if total is over 7½% of your income)

State or Local Sales Taxes Paid (or we will use the IRS tables) Additional deduction for a car or other large purchase in 2020.

Home Mortgage Interest Paid--Form 1098 (includes Mortgage Insurance which is still deductible)

Charitable Contributions (cash and non-cash charitable donations- YOU must estimate the values for each non-cash item

IRA Contributions

TEACHERS: You are *still* eligible for the deduction for up to \$250 of classroom expenses you paid.

Student Loan Interest--Form 1098-E.

IMPORTANT CREDITS

and...

To have your tax refund *Direct Deposited* to your bank, bring a **voided check** from that account **if different from last year**. *Estimated Taxes Paid--Dates and amounts of each estimated tax payment made towards your year 2020 tax liability.*

Any other Form 1098 or 1099 not mentioned above.

Notices from IRS or other taxing authorities or any other documents that you think may affect your tax.
